Texas Health Steps Policy Changes – Developmental and Mental Health

Screenings

Please review the important information below related to recent updates to Texas Health Steps Preventive Medical Checkups.

Changes to the Texas Health Steps (THSteps) Preventive Medical Checkups policy became effective June 1, 2021. Policy changes included the addition of the Survey of Well-being of Young Children (SWYC) as an approved developmental screening tool for children, and the Rapid Assessment for Adolescent Preventive Services (RAAPS) screening tool as an approved mental health screening tool for adolescents.

As a result of the policy changes the THSteps Periodicity Schedule as well as other important THSteps forms and provider tools have been updated.

Texas Health Steps (THSteps) Periodicity Schedule

The current Periodicity Schedule indicates a June 1, 2021 date. The front side of the Periodicity Schedule (checkup ages birth through 10 years) now includes the Survey of Well-being of Young Children (SWYC) screening tool within the Developmental Surveillance column. The back side of the Periodicity Schedule (checkup ages 11 through 20 years) now includes the Rapid Assessment for Adolescent Preventive Services (RAAPS) screening tool within the Mental Health column. Minor changes were made to some webpage addresses and links.

SWYC and RAAPS Screening Tools
