Re: National Drug Code (NDC) Billing Requirements

Update to fax blast sent on November 12, 2013. It is *Optional*, not a requirement on box 24D plus 24G to submit the quantity of units and unit of measurements information. Claims will not deny if your system is set up to submit the units or measurements of the administered drug.

Reminder: During the carve-in of pharmacy benefits effective March 1, 2012, the Texas Health and Human Services Commission (HHSC) mandated all Managed Care Health Plans to require a National Drug Code (NDC) on ALL medical claims for provider-administered drugs by Primary Care Providers, Specialty Care Providers, Outpatient Hospital Departments and all other provider administered drugs to patients in an outpatient setting. El Paso First is required to deny or reject the entire claim for any provider-administered drug when it is missing NDC code; the NDC is not valid for the corresponding Healthcare Common Procedure Coding System (HCPCS) code; and/or if the NDC is not 11 characters long. *Providers may resubmit claims by adding the appropriate NDC code when a claim is Denied with denial reason: M119: Missing/incomplete/invalid/withdrawn National Drug Code (NDC),*

Providers are encouraged to consult with applicable resources to identify the appropriate crosswalk for NDC and HCPCS codes. For example, a NDC to HCPCS crosswalk is published by Noridian Administrative Services, LLC. The crosswalk provides a listing of the NDC codes that are assigned to a HCPCS. Although, the crosswalk is a good resource for Providers it may not contain a complete listing of all NDCs codes to include vaccination codes.

NDC

Each NDC must be reported as an 11-digit code unique to the manufacturer of the specific drug or product administered to the beneficiary, using a 5-4-2 format *(i.e.,* 5 digits, followed by 4 digits, followed by 2 digits [99999999999]).

Some NDCs may be in a 10-digit format. The chart below illustrates how to convert the code into 11-digits. (Hyphens in the example below are for illustration only.)

10-Digit Format on Package	10-Digit Format Example	11-Digit Format	11-Digit Format Example

NDC Quantity

The quantity of each NDC must be a numeric value greater than zero. In most cases, the NDC quantity will be different from the HCPCS billed units.

NDC Unit of Measurement

The unit of measurement (UOM) for each NDC must be submitted.
