## ROUTINE PREVENTIVE SERVICES FOR CHILDREN AND ADOLESCENTS (12 YEARS- 20 YEARS)

The following guideline provides recommendations for routine preventive services for children 12 years to 20 years. Children at increased risk may warrant additional services.

<b>History:</b> Documentation must contain an initial health history and each subsequent checkup must contain information on an interim history.	x	x	x	x	x	x	x	x	x
<b>Mental Health Screening:</b> Mental health screening is required at each checkup and includes behavioral, social, and emotional development. Mental health screening using one of the following validated, standardized mental health screening tool is required once between the ages of 12 and 18 years of age: <ul style="list-style-type: none"> <li>•Patient Health Questionnaire-9 (PHQ-9)</li> <li>•Pediatric Symptom Checklist (PSC-17 and PSC-35)</li> <li>•Pediatric Symptom Checklist Youth Report (Y-PSC)</li> <li>•Car, Relax, Alone, Forget, Family, and Trouble Questionnaire (CRAFTT)</li> </ul> <a href="http://brightfutures.aap.org/tool_and_resource_kit.html">http://brightfutures.aap.org/tool_and_resource_kit.html</a>	x	x	x	x	x	x	x	x	x
	Mandatory screening with PHQ9, PSC-17, PSC-35, Y-PSC, or CRAFTT once during 12-18 years								
<b>Tuberculosis Screening:</b> TB Questionnaire must be administered annually beginning at 12 months of age. A Tuberculin Skin Test is to be administered when the screening tool indicates a risk for possible exposure	x	x	x	x	x	x	x	x	x
<b>Nutrition Screening :</b> Dietary practices should be assessed to identify unusual eating habits such as pica, extended use of baby bottle feedings, or eating disorders in older children and adolescents. For nutritional problems, further assessment is indicated.	x	x	x	x	x	x	x	x	x
<b>Age Appropriate Screening &amp; Administration of Immunizations:</b> Providers must assess the immunization status of clients at every medical checkup and vaccines must be administered according to the current Advisory Committee on Immunization Practices (ACIP). <b>Laboratory Tests:</b> <ul style="list-style-type: none"> <li>•Risk Based Tests: Screenings performed based on risk assessments include screenings for type 2 diabetes (dia), hyperlipidemia (dys), gonorrhea, chlamydia, syphilis (std) and HIV (hiv). <b>Age Appropriate Anticipatory Guidance &amp; Health Education:</b> Health education is designed to help parents and caregivers understand what to expect in terms of the child's development and to provide information for all ages about the benefits of healthy lifestyles and practices, as well as accident and disease prevention. <b>Dental:</b> Limited oral screening for caries and general health of the teeth and oral mucosa is part of the physical examination.
