## WACG Weight Assessment & Counseling for Nutrition & Physical Activity for Children/Adolescents (3-17 yrs)

- Include distinct BMI Percentile (not a range, >95 or “High/Low”) or plotted growth chart
- Include Anticipatory Guidance or checklist for Diet and Exercise
- Documentation of “appetite” does not meet criteria
- Discussion of nutrition behaviors and physical activity behaviors

## LSCG Lead Screening in Children (by 2nd birthday)

- Include Lab Results for Blood Lead Screening
- Include documentation stating when the test was performed and its results

## PPCG Prenatal and Postpartum Care

- Prenatal care in the first trimester or within 42 days of enrollment
- Postpartum visit on or between 7 and 84 days after delivery with notation of “postpartum care”

## IMAA Immunizations for Adolescents (by 13th birthday)

- Complete HPV series between 9th and 13th birthday
- One Tdap between 10th and 13th birthday
- One Meningococcal serogroups A, C, W, Y between 11th and 13th birthday

## EED Eye Exam for Patients with Diabetes (18-75 yrs)

- Retinal eye exam from eye specialist
- Evidence/notation of bilateral eye enucleation.

## HBD Hemoglobin A1C for Patients with Diabetes (18-75 yrs)

- Include most recent HbA1c level (goal <8%)

## COL Colorectal Cancer Screening (45-75 yrs)

- Include documentation indicating the date the colorectal cancer screening was performed.

## CBP Controlling High Blood Pressure (18-85 yrs)

- Include most recent blood pressure (goal <140/90)
- Include B/P taken by member with any digital device for remote monitoring

# TRC

## Transitions of Care (18 yrs and older)

- Notification of Inpatient admission: Include evidence of receipt of notification of inpatient admission on the day of admission through 2 days after the admission (3 total days).
- Receipt of Discharge Information: Include evidence of receipt of discharge summary through 2 days after the discharge (3 total days) with evidence of the date when the documentation was received.
- Patient Engagement After Inpatient Discharge: Include documentation of office visit, telephone visit or telehealth visit of patient engagement within 30 days after discharge.
- Medication Reconciliation Post-Discharge: Include evidence of medication reconciliation and date when it was performed.

## Blood Pressure Control for Patients with Diabetes (18-75 yrs)

- Identify the most recent blood pressure reading during the measurement year.
- Include B/P taken by member with any digital device for remote monitoring

## Childhood Immunization Status (by 2nd birthday)

- Review immunization record before every visit and administer needed vaccines
- Recommend and administer Annual Flu Immunization
- Complete Rotavirus series

# COA

## Care for Older Adults (66 yrs and older)

- Medication Review: Include current medication list, or notation of medication review.
- Functional Status Assessment: Notation that at least 5 ADLs were assessed (bathing, dressing, eating, transferring, using toilet, walking), notation of at least 4 IADL were assessed (shopping for groceries, driving or using public transportation, using the telephone, meal preparation, housework, home repair, laundry, taking medications, handling finances).
- Pain Assessment: Result of standardized pain assessment tool, or numeric rating scales (verbal or written)
